Shannon O'Hara is the Senior Legal Counsel to the Aviation Team at QBE Insurance Australia Pacific (QBE). In this role she partners with the aviation underwriting, industry development and aviation claims teams to efficiently assess and provide legal guidance on underwriting risk exposures, aviation litigation and claims strategies and general insurance law matters affecting the aviation business. She has been included in the #celebratingwomeninlaw campaign recognising women who have had an influence on the legal profession, in 2015 was identified by Australasian Lawyer as one of "50 Women to Watch / Experts in their Field" and has been recognised by Best Lawyers (Aviation) in 2018 and 2019 (prior to leaving private legal practice).

Shannon speaks regularly at industry events including the Avalon Air Show; the Women in Aviation (Australian Chapter) National Conference; the Association of South Pacific Airlines bi-annual conferences, and the Australian Helicopter Industry Association's Bi-Annual Rotor-tech Conference and the Australian Aviation Insurance Industry Forum.
