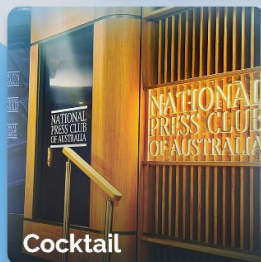

The committee looks forward to seeing you in Canberra, 2026.

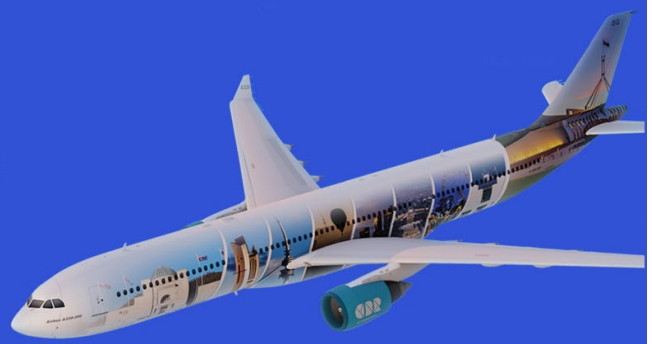

Conference Venues

Old Parliament House, located in the national parliamentary triangle, was the seat of the Parliament of Australia from 1927 to 1988. The venue is surrounded by gardens. It is situated in front of the current Parliament House and looks across Lake Burley Griffin to the Australian War Memorial where the conference dinner will be held.

Today, Old Parliament House has become a museum, preserving the building and its history. The building is officially known as the Museum of Australian Democracy at Old Parliament House.

The conference sessions will be held in Members' Dining Rooms which have sweeping views up to the current Parliament House. On the last day a session will be held in the House of Representatives Chamber.

The cocktail function will be held at the National Press Club of Australia. The venue is a nationally recognised institution, hosting debates and discussions that shape Australia today and into the future.

The new ANZAC Atrium at the Australian War Memorial has been chosen for the conference dinner to provide delegates with a unique experience. Delegates will be seated amidst some impressive artefacts from the War Memorial's collection.

The conference hotel is Hotel Kurrajong, Canberra. The hotel is heritage listed and offers stylish, luxury accommodation. The hotel opened in 1926 at the birth of the nation's capital and is steeped in political history.

Hotel Kurrajong is close to Old Parliament House and the National Press Club. Buses will pick up and drop off from the hotel for the dinner at the Australian War Memorial.

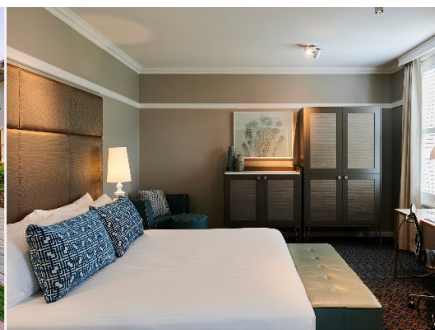
